

# Dear Members of the FIPS Mouche,

Let us invite you on behalf of all members of the South Bohemian and West Bohemian Boards of the Czech Anglers Union and of the Organisation Committee to the 44<sup>th</sup> World Fly Fishing Championship, to be held in South and West Bohemia, Czech Republic, from May 25 till May 31, 2025.

#### **Important dates**

Final registration by January 31, 2025

Payment by February 28, 2025

### Fees

The headquarter of the championship will be located in the Wellness Hotel Frymburk. The basic fee was calculated for two persons in a double room. In the case of single rooms, we have to ask for extra payment. Hotels also offers family apartments where can be accommodated up to 4 persons and we offer also this possibility.

Fees include 6 nights, full day board meal (starting from lunch on Saturday May 25, 2025) and two banquets. Fees for the members of teams also includes one-month Czech state rod licence and fishing permit valid for competition venues during the Championship.

# **Registration**

Registration will be processed in two steps:

- We would like to ask you register one-line through FIPS MOUCHE website, the registration will be based on the rule first registered-first chooses according to the available capacity of rooms in the hotel. The deadline for the registration is January 31, 2025. Please, fill all names, contact details for captain and manager, required type of rooms and also request for a special diet if required
- 2) We will check registration, book rooms for you according to your requests, and we will calculate your fee and send you an invoice. The deadline for the payment is February 28, 2025.

# **Fishing licences**

To arrange the Czech state rod licences and fishing permits, we need to receive by e-mail a completed application form for every attendant and a copy of ID card or passport by the end of February 2025. The application form will be published on the website.

For any practice before the Championship, it is necessary to buy fishing permits, all details can be found on the website, we can help to arrange it in advance.

**Rules modifications** will be published on the website and will be explained and discussed during the Captains' meeting.

### **Competition venues**

Description of all the venues including maps and pictures will be found on the website.

### Practice

The fishing in competition sectors by competitors or their agents is prohibited during a period of thirty days prior to the official start of the event (from April 25, 2025) with one exception. The practice on Květoňov lake will be extended until May 3, 2025, when the last local competition will be held on the lake. Any attendant of the Championship is eligible to participate in the event.

Practice waters for all venues will be published on the website.
