SUBJECT: Addition to the application for the organization of the World Youth Championship 2020;

Dear Sirs,

The Sports Fishing Association of Bosnia and Herzegovina sincerely believe that You will approved the organization of the World Youth Championship 2020 at the fourthcomming meeting of the Steering Committee.

Regarding your letter that you sent to us (letter recived after the meeting of the Fips Mouche Board in regard with the 35th World Cup in January 2015) where you noted certain complaints regarding accommodation, food, uneven quantities of fish by sector, incorrect trials, fish correspondence, competitors' nutrition, etc, we are informing you that the Sports Fishing Association of Bosnia and Herzegovina Steering Committee was analyzed all above mentioned complaints and accepted all your suggestions, because we realize that you paid attention to all of these complaints with the best intent as such things are never repeated on future championships.

Because all the previously mentioned we strongly promise You the realization of the following activities:

1. Special attention will be paid to the training of judges, which we will do with the assistance of foreign experts, where we will determine true and fair fishermen who understand this discipline;
2. We will carry out a special audit and monitoring of the work of our judges, engaging supervisors from our own and other countries, who will perform additional controls in order to do all this in the best possible way;
3. The competition will take place on the River Una located in the village Kulen Vakuf close to the place called Martin Brod, and owned by the National Park "Una" Bihać, from which we were get the approval for the organization of the championship;
4. The competition venues (where the championship will take place) already has a plenty of fish, and if necessary, an additional quantity of fish will be added and equally distributed across all sectors;
5. River Una (river where the competition will be held) is rich with trout, grayling and huco huco, and in the lower course there are significant quantities of white fish;
6. The competition on standing water will be organized from the coast, not from the boats;
7. The city of Bihać has a large number of hotels and motels, in which, a large number of competitors and guests can be accommodated (hotel "Park", hotel "Kostelski buk", hotel



- "Pavilion", hotel "Swiss Plus" ... and others) and a central events (opening ceremony, closing ceremony, press center) will be organized and situated at the hotel "Park" in the city center;
8. In the Press center will be separate conference rooms, captain's meetings rooms, special room for Fips Mouche officials, internet room and also a place for complete equipment;
 9. Distance of the competition venues from the Press center and the hotel is maximum 25 kilometers;
 10. Meals for competitors and guests will be organized in accordance with current standards and quality;
 11. The closest airport is in the city of Zagreb, approximately 160 kilometers highway away from city of Bihać.

Dear Sirs,

In order to act on your suggestions, we sincerely believe that you will accept all of above mentioned activities, approved us the organization of the World Youth Championship 2020 and join us at the World Youth Championship 2020 on beautiful river Una in the city of Bihać.

Attached to the letter you will find the approval from National Park "Una" Bihać and from the Mayor of the city of Bihać, which are also gave us a strong promise that this championship will be high level organized.
